

**THE TOWN OF MOUNT AIRY  
ORDINANCE NO. 2019-6**

AN ORDINANCE TO AMEND ORDINANCE 2019-3, WHICH ADOPTED AND APPROVED THE BUDGET FOR THE TOWN OF MOUNT AIRY FOR FISCAL YEAR 2019-2020.

FOR THE PURPOSE OF AMENDING THE BUDGET BY ADDING \$9,900 TO THE GENERAL FUND CAPITAL BUDGET RAILS TO TRAILS EAST OF MAIN STREET PROJECT FOR A COMMUNITY PICNIC AREA IN THE TOWN VIEW SUBDIVISION WITH FUNDS COMING FROM A PARKS RESERVE ACCOUNT.

WHEREAS, the plan for the Rails to Trails East of Main Street Project includes installing a recreational area in the Town View Subdivision which will become property of the Town View Home Owners Association; and

WHEREAS, the recreational area was a project funded in Fiscal Year 2018-2019, but the project was not ready to move forward before the end of the fiscal year; and

WHEREAS, the Home Owners Association has decided that they would like to have a Community Picnic area installed as the project; and

WHEREAS, the project is ready to move forward in Fiscal Year 2019-2020; and

WHEREAS, the Town Council wishes to allocate funds for the expenses of this project; and

WHEREAS, the Town Council of Mount Airy Adopted Ordinance 2019-3 adopting the Budget for Fiscal Year 2019-2020 for the Town of Mount Airy on May 6, 2019; and

WHEREAS, the Town Council wishes to amend Ordinance 2019-3 as follows:

NOW THEREFORE, BE IT RESOLVED that the Town of Mount Airy Budget for Fiscal Year 2019-2020 be, and hereby is, amended to add \$9,900 to the Rails to Trails East of Main Street line item for the Town View Community Picnic Area project, with funding coming from a Parks Reserve Investment Account; and that all other provisions of Ordinance 2019-3 shall remain unchanged and as is.
