

**THE TOWN OF MOUNT AIRY  
ORDINANCE NO. 2019-14**

AN ORDINANCE TO AMEND ORDINANCE 2019-3, WHICH ADOPTED AND APPROVED THE BUDGET FOR THE TOWN OF MOUNT AIRY FOR FISCAL YEAR 2019-2020.

FOR THE PURPOSE OF AMENDING THE BUDGET BY ADDING \$18,200 TO THE GENERAL FUND OPERATING BUDGET FOR CLEANING SERVICES WITH FUNDS COMING FROM THE GENERAL FUND OPERATING SAVINGS ACCOUNT.

WHEREAS, The Town solicited bids for cleaning services for Town Hall, the Train Station and the Police Station to begin on July 1, 2019; and

WHEREAS, the lowest bid was accepted at \$7,287 per year, contingent upon the completion of a background check; and

WHEREAS, the company that won the bid did not pass the background check; and

WHEREAS, the Town wishes to contract with the second lowest bidder, whose services were bid at \$25,480 per year, and was the Town's previous cleaning service company; and

WHEREAS, the Town Council wishes to provide funding for the additional cost of the second lowest bidder for cleaning services in Fiscal Year 2019-2020; and

WHEREAS, the Town Council of Mount Airy Adopted Ordinance 2019-3 adopting the Budget for Fiscal Year 2019-2020 for the Town of Mount Airy on May 6, 2019; and

WHEREAS, the Town Council wishes to amend Ordinance 2019-3 as follows:

NOW THEREFORE, BE IT RESOLVED that the Town of Mount Airy Budget for Fiscal Year 2019-2020 be, and hereby is amended to add \$18,200 to the Cleaning Services line items: \$9,670 for Town Hall, \$7,220 for the Police Station, and \$1,310 for the Train Station, with funding coming from the General Fund Operating Savings Account; and that all other provisions of Ordinance 2019-3 shall remain unchanged and as is.

**If so desired, that upon the affirmative vote of four members of the Council, the provisions of C2-13(B) of the Charter of the Town of Mount Airy are hereby suspended and this measure is declared to be an emergency measure effective upon approval.**
